As of 1.01.2020, Eesti Elektroonikaromu OÜ will not issue invoices smaller than 10 Euros + VAT. If the customer's invoice is less than 10 EUR, we'll charge invoice fee of 10 EUR + VAT.

If you are a small importer, we recommend that you report less frequently - for quarterly reporting, invoice 1x per year.

- \*Due to the long-term use of Li-Ion (NMC/NCA) and LiFePO4 (LFP) storage batteries, Eesti Elektroonikaromu OÜ has the right to charge a surcharge from the Manufacturer if the recycling prices change when battery waste is generated, if the recycling prices are 10% or more higher than the tariff according to the price list.
- \*\* The category is taxed based on waste generation, not on placing on the market, the prices of which may change according to the currently applicable recycling prices.
